

The following reports the results of every Special and General Court-Martial tried within the United States Navy in April 2021. The cases are separated by the Navy Region in which they were tried.

Naval District Washington

General Court-Martial

- At a General Court-Martial in Washington, D.C., HM3 Martin K. Ndichu, USN, pled guilty pursuant to a plea agreement to wrongful use of a controlled substance and larceny of military property. On 5 April 2021, consistent with the plea agreement, the military judge sentenced him to a reprimand, forfeit \$330 per month for 12 months, reduction in rank to paygrade E-1, and hard labor without confinement for 90 days. The plea agreement contained a waiver of the accused's administrative separation board.
- At a General Court-Martial in Washington, D.C., HMCM Gregory F. Fall, USN, pled guilty pursuant to a plea agreement to wrongfully engaging in unprofessional conduct by kissing the mouth and touching the breast of another Service Member in his office. On 12 April 2021, consistent with the plea agreement, the military judge sentenced him to reduction in rank to paygrade E-8.
- At a General Court-Martial in Washington, D.C., CTT1 D'Urville A. Christopher, USN, was tried for assault consummated by a battery upon a child under 16 years and attempted indecent acts with a child. On 21 April 2021, the military judge returned a verdict of guilty of assault consummated by a battery upon a child under 16 years and sentenced him to confinement for 345 days.

Special Court-Martial

- At a Special Court-Martial in Great Lakes, Illinois, SA Alexander J. Guinan, USN, pled guilty pursuant to a plea agreement to assault consummated by a battery and two specifications of assault. On 7 April 2021, consistent with the plea agreement, the military judge sentenced him to forfeit \$285 per month for 2 months and reduction in rank to paygrade E-1. The plea agreement contained a waiver of the accused's administrative separation board.

- At a Special Court-Martial in Norfolk, Virginia, CSSN Jorge A. Guevara, USN, pled guilty pursuant to a plea agreement to wrongful distribution of a controlled substance and wrongful introduction of a controlled substance with intent to distribute. On 9 April 2021, consistent with the plea agreement, the military judge sentenced him to reduction in rank to paygrade E-1, confinement for 120 days, and a Bad Conduct Discharge.
- At a Special Court-Martial in Great Lakes, Illinois, LCDR Jason D. Doan, USN, pled guilty pursuant to a plea agreement to three specifications of willfully disobeying a superior commissioned officer by violating a military protective order. On 13 April 2021, consistent with the plea agreement, the military judge sentenced him to a reprimand and to forfeit \$1,000 per month for 9 months. Pursuant to the plea agreement, all forfeitures in excess of \$1,000 per month for 1 month will be suspended. The suspended forfeitures may be served if the Service Member violates the terms of the plea agreement. The plea agreement contained a waiver of the accused's board of inquiry.
- At a Special Court-Martial in Norfolk, Virginia, AD3 David I. Weaver, USN, pled guilty pursuant to a plea agreement to two specifications of indecent recording for recording the private area of another person without their consent. On 14 April 2021, consistent with the plea agreement, the military judge sentenced him to reduction in rank to paygrade E-1, confinement for 180 days, and a Bad Conduct Discharge.
- At a Special Court-Martial in Norfolk, Virginia, SN Joel M. Ash, USN, pled guilty pursuant to a plea agreement to wrongful distribution of a controlled substance, wrongful introduction of a controlled substance, three specifications of wrongful use of a controlled substance, and obstruction of justice. On 30 April 2021, consistent with the plea agreement, the military judge sentenced him to reduction in rank to paygrade E-1, confinement for 9 months, and a Bad Conduct Discharge.

Navy Region Southeast

General Court-Martial

- At a General Court-Martial in Jacksonville, Florida, HM2 Rill A. Thompson, USN, was tried for four specifications of sexual assault of a child and one specification of sexual abuse of a child. On 2 April 2021, the panel of members returned a verdict of guilty of two specifications of sexual assault of a child and one specification of sexual abuse of a child and sentenced him to confinement for 21 years and a Dishonorable Discharge.
- At a General Court-Martial in Mayport, Florida, an E-3, USN, was tried for sexual assault. On 8 April 2021, the panel of members returned a verdict of not guilty.
- At a General Court-Martial in Pensacola, Florida, an E-5, USN, was tried for sexual assault, abusive sexual contact, and sexual harassment. On 15 April 2021, the panel of members returned a verdict of not guilty.

- At a General Court-Martial in Mayport, Florida, LTJG Christopher A. Robinson, USN, pled guilty pursuant to a pretrial agreement to assault consummated by a battery and conduct unbecoming an officer and gentleman for fraternization. On 15 April 2021, the military judge sentenced him to a reprimand, fine of \$3,000, restriction for 30 days, and confinement for 7 days. The pretrial agreement had no effect on his sentence. The pretrial agreement contained a waiver of the accused's board of inquiry.
- At a General Court-Martial in Mayport, Florida, GSM3 Andrew M. Futch, USN, pled guilty pursuant to a plea agreement to attempted enticement of a minor to engage in sexual activity that would have constituted sexual assault of a child in violation of 18 U.S. Code Section 2422(b). On 19 April 2021, consistent with the plea agreement, the military judge sentenced him to reduction in rank to paygrade E-1, confinement for 15 months, and a Bad Conduct Discharge.
- At a General Court-Martial in Pensacola, Florida, an E-7, USN, was tried for sexual assault. On 23 April 2021, the panel of members returned a verdict of not guilty.
- At a General Court-Martial in Mayport, Florida, MM2 Wyatt C. Kalbrener, USN, pled guilty pursuant to a plea agreement to distribution of child pornography, possession of child pornography, and indecent language. On 28 April 2021, consistent with the plea agreement, the military judge sentenced him to confinement for 5 years and a Dishonorable Discharge.
- At a General Court-Martial in Pensacola, Florida, an E-4, USN, was tried for sexual assault. On 29 April 2021, the panel of members returned a verdict of not guilty.
- At a General Court-Martial in Jacksonville, Florida, an E-5, USN, was tried for three specifications of rape, three specifications of sexual assault, conspiracy to commit rape, conspiracy to commit sexual assault, and false official statement. On 30 April 2021, the military judge returned a verdict of not guilty.

General Court-Martial

- At a General Court-Martial in Bremerton, Washington, an E-2, USN, was tried for four specifications of sexual assault and extortion. On 7 April 2021, the panel of members returned a verdict of not guilty.

Special Court-Martial

- At a Special Court-Martial in Bremerton, Washington, AM3 Miguel J. Martinez, USN, pled guilty pursuant to a plea agreement to fraudulent use of a credit card. On 21 April 2021, consistent with the plea agreement, the military judge sentenced him to reduction in rank to paygrade E-1 and confinement for 35 days. The plea agreement contained a waiver of the accused's administrative separation board.
- At a Special Court-Martial in Everett, Washington, LSC Stacey M. Sobieski, USN, pled guilty pursuant to a plea agreement to wrongful appropriation. On 23 April 2021, consistent with the plea agreement, the military judge sentenced her to reduction in rank to paygrade E-6. The plea agreement contained a waiver of the accused's administrative separation board.

Navy Region Southwest

General Court-Martial

- At a General Court-Martial in San Diego, California, AN Sanqwan D. Allen, USN, was tried for three specifications of aggravated assault upon his spouse. On 26 April 2021, the panel of members returned a verdict of guilty of assault consummated by a battery upon his spouse and sentenced him forfeit \$1,000 per month for 2 months, reduction in rank to paygrade E-2, and restriction for 30 days.

Special Court-Martial

- At a Special Court-Martial in San Diego, California, HN Austin M. Chroma, USN, pled guilty pursuant to a plea agreement to five specifications of wrongful distribution of a controlled substance. On 15 April 2021, consistent with the plea agreement, the military judge sentenced him to reduction in rank to paygrade E-1, confinement for 6 months, and a Bad Conduct Discharge.

Navy Region Hawaii

General Court-Martial

- At a General Court-Martial in Pearl Harbor, Hawaii, an E-5, USN, was tried for sexual assault, communicating a threat, and assault consummated by a battery. On 22 April 2021, the panel of members returned a verdict of not guilty.
