

The following reports the results of every Special and General Court-Martial tried within the United States Navy in December 2022. The cases are separated by the Navy Region in which they were tried.

Naval District Washington

Navy Region Mid-Atlantic

General Court-Martial

- At a General Court-Martial in Norfolk, VA, an E-7, USN, was tried for violations of two specifications of sexual assault. On 15 December 2022, the military judge returned a verdict of not guilty to both specifications.
- At a General Court-Martial in Great Lakes, IL, FCSN Caleb Rouse, USN, pled guilty pursuant to a plea agreement to two specifications of attempted sexual abuse of a child involving indecent communications and one specification of attempted receipt of child pornography. On 20 December 2022, consistent with the plea agreement, the military judge sentenced him to 8 months confinement, a Bad Conduct Discharge, and reduction in paygrade to E-1.

Special Court-Martial

- At a Special Court-Martial in Norfolk, Virginia, ITS2 Samuel Elbert, USN, pled guilty pursuant to a plea agreement to one specification of obstructing justice. On 8 December 2022, consistent with the plea agreement, the military judge sentenced him to 12 months confinement, a Bad Conduct Discharge, and reduction in paygrade to E-1.
- At a Special Court-Martial in Norfolk, VA, MMFA David Guajardo, Jr., USN, pled guilty pursuant to a plea agreement to one specification of domestic violence involving strangulation of an intimate partner, one specification of unlawful entry, and one specification of assault consummated by a battery. On 14 December 2022, consistent with the plea agreement, the military judge sentenced him to 7 months confinement and a Bad Conduct Discharge.

Navy Region Southeast

General Court-Martial

- At a General Court-Martial in Jacksonville, Florida, MMNFR Dylan Dioguardi, USN, was tried for violations of three specifications of assault consummated by a battery upon an intimate partner, one specification of destruction of property other than military property, and one specification of failure to obey a lawful written order. On 16 December 2022, the panel of members returned a verdict of guilty to three specifications of assault consummated by a battery upon an intimate partner and to one specification of destruction of property other than military property. On 16 December 2022, the panel of members sentenced him to 6 months confinement.
- At a General Court-Martial in Mayport, Florida, MNSN Vincent Cuneo, USN, pled guilty pursuant to a plea agreement to one specification of failing to obey other lawful order and one specification of distributing child pornography. On 21 December 2022, consistent with the plea agreement, the military judge sentenced him to 146 days confinement, a Bad Conduct Discharge, and reduction in paygrade to E-1.

Special Court-Martial

- At a Special Court-Martial in Pensacola, Florida, UTCA Christian Gonzalez, USN, pled guilty pursuant to a plea agreement to one specification of false official statement. On 16 December 2022, consistent with the plea agreement, the military judge sentenced him to forfeitures of one-half pay for 1 month and reduction in paygrade to E-2. The plea agreement contained a waiver of the accused's administrative separation board.
- At a Special Court-Martial in Pensacola, Florida, AA Islam Nabulsi, USN, pled guilty pursuant to a plea agreement to one specification of wrongful use of a controlled substance. On 19 December 2022, consistent with the plea agreement, the military judge sentenced him to forfeitures of two-thirds pay for 2 months and reduction in paygrade to E-1. The plea agreement contained a waiver of the accused's administrative separation board.
- At a Special Court-Martial in Pensacola, Florida, SWCA Kevin Reinhart, USN, pled guilty pursuant to a plea agreement to one specification of wrongful use of a controlled substance. On 20 December 2022, consistent with the plea agreement, the military judge sentenced him to forfeitures of two-thirds pay for 2 months and reduction in paygrade to E-1. The plea agreement contained a waiver of the accused's administrative separation board.

Navy Region Northwest

General Court-Martial

- At a General Court-Martial in Bremerton, Washington, ITS3 Michael Guider, Jr., USN, pled guilty pursuant to a plea agreement to one specification of viewing child pornography. On 13 December 2022, consistent with the plea agreement, the military judge sentenced him to 24 months confinement, a Bad Conduct Discharge, forfeiture of pay and allowances for 24 months, and reduction in paygrade to E-1.

Special Court-Martial

- At a Special Court-Martial in Bremerton, Washington, AO1 Eddie Tyson, USN, pled guilty pursuant to a plea agreement to one specification of disorderly conduct. On 9 December 2022, consistent with the plea agreement, the military judge sentenced him to 76 days confinement.
- At a Special Court-Martial in Bangor, Washington, LCpl Myles Platt, USMC, pled guilty pursuant to a plea agreement to one specification of willful dereliction of duty and one specification of disorderly conduct. On 15 December 2022, consistent with the plea agreement, the military judge sentenced him to restriction for 2 months, reduction in paygrade to E-1, and forfeitures of two-thirds pay for 2 months. The plea agreement contained a waiver of the accused's administrative separation board.

- At a General Court-Martial in Pearl Harbor, Hawaii, FTSN Dylan Hitchcock, USN, pled guilty pursuant to a plea agreement to one specification of attempted sexual abuse of a child involving indecent communication, one specification of attempted sexual abuse of a child involving indecent exposure, one specification of distributing child pornography, and one specification of receiving, possessing and viewing child pornography. On 6 December 2022, consistent with the plea agreement, the military judge sentenced him to 39 months confinement, a Dishonorable Discharge, reduction in paygrade to E-1, and forfeiture of all pay and allowances.
