  19 January 2021, the military judge sentenced him to reduction in rank to paygrade E-1,
  confinement for 4 months, and a Bad Conduct Discharge. The pretrial agreement had no
  effect on his sentence.
- At a General Court-Martial in Norfolk, Virginia, LT Jeremy J. Stack, USN, pled guilty pursuant to a pretrial agreement to attempted sexual abuse of a child and conduct unbecoming an officer and a gentleman for lewd and sexual conversations pertaining to sexual acts with children. On 21 January 2021, the military judge sentenced him to confinement for 10 months and a Dismissal. The pretrial agreement had no effect on his sentence.
- At a General Court-Martial in Norfolk, Virginia, SOC Tony E. Dedolph, USN, pled guilty pursuant to a pretrial agreement to conspiracy to commit assault, conspiracy to obstruct justice, involuntary manslaughter, hazing, and obstruction of justice. On 23 January 2021, the panel of members sentenced him to reduction in rank to paygrade E-1, forfeit all pay and allowances, confinement for 10 years, and a Dishonorable Discharge. The pretrial agreement had no effect on his sentence.

On 26 January 2021, consistent with the pretrial agreement, the military judge sentenced him to reduction in rank to paygrade E-3, confinement for 7 months, and a Bad Conduct Discharge.
- At a General Court-Martial in Charleston, South Carolina, EMN1 Jaime P. Bontekoe, USN, pled guilty pursuant to a pretrial agreement to two specifications of assault consummated by a battery upon an intimate partner. On 27 January 2021, consistent with the pretrial agreement, the military judge sentenced him to reduction in rank to paygrade E-4, confinement for 24 months, and a Bad Conduct Discharge.
