#### **General Court-Martial**

• At a General Court-Martial in Norfolk, Virginia, LSSN Roberto Rios, USN, pled guilty pursuant to a plea agreement to sexual assault and unlawful entry. On 20 January 2022, consistent with the plea agreement, the military judge sentenced him to forfeit all pay and allowances, reduction to paygrade E-1, confinement for 12 months, and a Dishonorable Discharge.

### **Special Court-Martial**

- At a Special Court-Martial in Great Lakes, Illinois, FCSN Maximus L. Werry, USN, pled guilty pursuant to a plea agreement to two specifications of wrongful use of a controlled substance and two specifications of wrongful possession of a controlled substance. On 25 January 2022, consistent with the plea agreement, the military judge sentenced him to reduction in paygrade to E-1, confinement for 5 months, and a Bad Conduct Discharge.
- At a Special Court-Martial in Great Lakes, Illinois, GSEFR Joel M. Norman, USN, pled guilty pursuant to a plea agreement to assault consummated by a battery. On 27 January 2022, consistent with the plea agreement, the military judge sentenced him to confinement for 2 months and a Bad Conduct Discharge
- At a Special Court-Martial in Norfolk, Virginia, AWFAN Deems Yee II, USN, pled guilty pursuant to a plea agreement to fraudulent enlistment, violation of a lawful general order for failing to report personal foreign travel, and violation of a lawful general order for failing to report foreign connections. On 28 January 2022, consistent with the plea agreement, the military judge sentenced him to reduction in paygrade to E-1, confinement for 210 days, and a Bad Conduct Discharge.

• At a Special Court-Martial in Norfolk, Virginia, ET3 Brett V. Yang, USN, pled guilty pursuant to a plea agreement to wrongful possession of a controlled substance, wrongful use of a controlled substance, wrongful distribution of a controlled substance, wrongful introduction of a controlled substance, and conspiracy to commit wrongful distribution of a controlled substance. On 28 January 2022, consistent with the plea agreement, the military judge sentenced him to reduction in paygrade to E-1, confinement for 135 days, and a Bad Conduct Discharge.

## **Navy Region Southeast**

#### **General Court-Martial**

- At a General Court-Martial in Jacksonville, Florida, an O-3, USN, was tried for rape of a child and two specifications of sexual abuse of a child involving sexual contact. On 20 January 2022, the panel of members returned a verdict of not guilty.
- At a General Court-Martial in Jacksonville, Florida, MMN2 Brandon W. Paige, USN, pled guilty pursuant to a plea agreement to three specifications of sexual abuse of a child involving indecent communications, two specifications of possession of child pornography, and one specification of attempted receipt of child pornography. On 28 January 2022, consistent with the plea agreement, the military judge sentenced him to reduction to paygrade E-1, confinement for 42 months, and a Dishonorable Discharge.

## **Special Court-Martial**

- At a Special Court-Martial in Charleston, South Carolina, ATAR Trajon A. Jeter, USN, pled guilty pursuant to a plea agreement to disobeying a petty officer and assault consummated by a battery. On 11 January 2022, consistent with the plea agreement, the military judge sentenced him to confinement for 60 days. Pursuant to the plea agreement all confinement is to be suspended. The suspended confinement may be served if the Service Member violates the terms of the plea agreement.
- At a Special Court-Martial in Mayport, Florida, an E-5, USN, was tried for wrongful use
  of a controlled substance. On 27 January 2022, the military judge returned a verdict of
  not guilty.
- At a Special Court-Martial in Mayport, Florida, HT2 Daniel L. Allred, USN, pled guilty pursuant to a plea agreement to two specifications of child endangerment. On 31 January 2022, consistent with the plea agreement, the military judge sentenced him to reduction in paygrade to E-1 and restriction for 60 days. The plea agreement contained a waiver of the accused's administrative separation board.

• At a General Court-Martial in Bremerton, Washington, EM3 Sergio Jacobo, USN, pled guilty pursuant to a plea agreement to sexual assault of a child. On 20 January 2022, consistent with the plea agreement, the military judge sentenced him to reduction in paygrade to E-1, confinement for 42 months, and a Dishonorable Discharge.

• At a Special Court-Martial in Bremerton, Washington, STGC Michael S. Rettus, USN (retired), pled guilty pursuant to a pretrial agreement to indecent language. On 12 January 2022, the military judge sentenced him to reduction in paygrade to E-5 and a Bad Conduct Discharge.

Chaplow, USN, was tried for nine specifications of assault consummated by a battery upon an intimate partner, one specification of assault, one specification of domestic violence by strangulation of an intimate partner, and one specification of conduct unbecoming an officer and a gentleman. On 14 January 2022, the panel of members returned a verdict of guilty to two specifications of assault consummated by a battery upon an intimate partner, one specification of assault, and one specification of conduct unbecoming an officer and a gentleman and sentenced him to a reprimand, forfeit \$5,300 per month for 9 months, and confinement for 9 months.
