

The following reports the results of Special and General Courts-Martial tried and completed within the United States Navy in July 2016. The cases are listed by the Navy Region in which they were tried.

Naval District Washington

Special Court-Martial

- At a Special Court-Martial in Washington, D.C., AD2 Niaz Suarez-Llanos, USN pled guilty pursuant to a pretrial agreement to resisting apprehension and driving with a suspended license. On 13 July 2016, the military judge sentenced him to forfeit \$1,000 per month for 2 months, reduction in rank to paygrade E-3, and confinement for 2 months. The pretrial agreement had no effect on his sentence.

Navy Region Mid-Atlantic

General Court-Martial

- At a General Court-Martial in Norfolk, Virginia, an E-3 was tried for sexual assault and false official statement. On 8 July 2016, the panel of members returned a verdict of not guilty.
- At a General Court-Martial in Norfolk, Virginia, OSC Sterlin D. Williams, USN pled guilty pursuant to a pretrial agreement to five specifications of child rape and four specifications of sexual abuse of a child. On 14 July 2016, the military judge sentenced him to be discharged with a Dishonorable Discharge, reduction in rank to paygrade E-1, to forfeit total pay and allowances, and confinement for 9 years and 10 months. The pretrial agreement had no effect on his sentence.
- At a General Court-Martial in Groton, Connecticut, an E-3 was tried for abusive sexual contact, indecent exposure, and assault consummated by a battery. On 21 July 2016, the panel of members returned a verdict of not guilty.
- At a General Court-Martial in Great Lakes, Illinois, an E-4 was tried for two specifications of sexual assault. On 21 July 2016, the panel of members returned a verdict of not guilty.

Special Court-Martial

- At a Special Court-Martial in Norfolk, Virginia, ABHAN Derrick S. Rodriguez, USN pled guilty pursuant to a pretrial agreement to abusive sexual contact. On 18 July 2016, the military judge sentenced him to confinement for 175 days. The pretrial agreement had no effect on his sentence.

Navy Region Northwest

General Court-Martial

- At a General Court-Martial in Bremerton, Washington, HT3 Lashod A. McIntosh, USN pled guilty pursuant to a pretrial agreement to four specifications of introduction, intent to distribute, and use of marijuana, cocaine, and MDMA. On 14 July 2016, the military judge sentenced him to be discharged with a Bad Conduct Discharge, reduction in rank to paygrade E-2, and confinement for 17 months. Pursuant to the pretrial agreement, all confinement greater than 12 months is to be suspended and remitted. The suspended confinement may be served if the Service Member violates the terms of the pretrial agreement.

Special Court-Martial

- At a Special Court-Martial in Bremerton, Washington, LCpl Leon M. Rosilloherrera, USMC pled guilty pursuant to a pretrial agreement to adultery and five specifications of permitting persons under the age of twenty-one to consume liquor on his premises. On 7 July 2016, the military judge sentenced him to reduction in rank to paygrade E-1 and confinement for 60 days. The pretrial agreement had no effect on his sentence.
- At a Special Court-Martial in Bremerton, Washington, AA Qaliek R. Thompson, USN pled guilty pursuant to a pretrial agreement to two specifications of unauthorized absence, false official statement, and assault consummated by a battery. On 11 July 2016, the military judge sentenced him to reduction in rank to paygrade E-1 and confinement for 90 days. Pursuant to the pretrial agreement, all confinement greater than 46 days is to be suspended and remitted. The suspended confinement may be served if the Service Member violates the terms of the pretrial agreement.
- At a Special Court-Martial in Bremerton, Washington, AOAN Adam J. Montalvo, USN pled guilty pursuant to a pretrial agreement to making a false official statement and twelve specifications related to wrongful use, possession, introduction, and attempted distribution of marijuana, cocaine, and MDMA. On 15 July 2016, the military judge

sentenced him to be discharged with a Bad Conduct Discharge, reduction in rank to paygrade E-1, and confinement for 8 months. Pursuant to the pretrial agreement, all confinement greater than 90 days is to be suspended and remitted. The suspended confinement may be served if the Service Member violates the terms of the pretrial agreement.

Navy Region Southwest

General Court-Martial

- At a General Court-Martial in San Diego, California, an E-4 was tried for sexual assault. On 14 July 2016, the panel of members returned a verdict of not guilty.
- At a General Court-Martial in San Diego, California, LCDR Joel C. Rolley, USN was tried for numerous offenses to include violating a lawful general regulation (attempting to influence body composition measurement) and disrespect toward a superior commissioned officer. On 21 July 2016, the panel of members found him guilty of violating a lawful general regulation and disrespect toward a superior commissioned officer and sentenced him to a reprimand.
- At a General Court-Martial in San Diego, California, GM1 Nicholas R. Fairbrother, USN pled guilty pursuant to a pretrial agreement to disobeying a superior commissioned officer, four specifications of disobeying a lawful order (inappropriate relationships with recruits), wrongful use of heroin, and four specifications of impeding an investigation. On 21 July 2016, the military judge sentenced him to be discharged with a Dishonorable Discharge, reduction in rank to paygrade E-1, and confinement for 22 months. The pretrial agreement had no effect on his sentence.

Navy Region Hawaii

General Court-Martial

- At a General Court-Martial in Pearl Harbor, Hawaii, ND1 Kevin C. Embleton, USN pled guilty pursuant to a pretrial agreement to possessing child pornography and wrongful use and possession of anabolic steroids. On 20 July 2016, the military judge sentenced him to be discharged with a Dishonorable Discharge, reduction in rank to paygrade E-1, and confinement for 20 months. The pretrial agreement had no effect on his sentence.

Navy Region Japan

General Court-Martial

- At a General Court-Martial in Yokosuka, Japan, IT2 Phosy Phanda, USN pled guilty pursuant to a pretrial agreement to attempted sexual assault of a child and attempted sexual abuse of a child. On 15 July 2016, the military judge sentenced him to be discharged with a Dishonorable Discharge, to forfeit all pay and allowances, reduction in rank to paygrade E-1, and confinement for 42 months. Pursuant to the pretrial agreement, all confinement greater than 30 months is to be suspended and remitted. The suspended confinement may be served if the Service Member violates the terms of the pretrial agreement.
