

The following reports the results of every Special and General Court-Martial tried within the United States Navy in June 2021. The cases are separated by the Navy Region in which they were tried.

Naval District Washington

General Court-Martial

Navy Region Mid-Atlantic

General Court-Martial

- At a General Court-Martial in Norfolk, Virginia, LS3 Curtis D. Johnson, USN, pled guilty pursuant to a pretrial agreement to aggravated arson and obstruction of justice. On 14 June 2021, the military judge sentenced him to reduction in rank to paygrade E-1, confinement for 36 months, and a Dishonorable Discharge. The pretrial agreement had no effect on his sentence.

Special Court-Martial

- At a Special Court-Martial in Norfolk, Virginia, ABHAA Daniel T. Carter, USN, pled guilty pursuant to a plea agreement to 11 specifications of larceny. On 1 June 2021, consistent with the plea agreement, the military judge sentenced him to reduction in rank to paygrade E-1 and a Bad Conduct Discharge.
- At a Special Court-Martial in Norfolk, Virginia, EMN2 Jacob D. Russell, USN, pled guilty pursuant to a plea agreement to wrongful manufacture of a controlled substance and wrongful distribution of a controlled substance. On 3 June 2021, consistent with the plea agreement, the military judge sentenced him to reduction in rank to paygrade E-1, confinement for 11 months, and a Bad Conduct Discharge.
- At a Special Court-Martial in Norfolk, Virginia, CECN Connor M. Knochel, USN, pled guilty pursuant to a plea agreement to two specifications of violation of a lawful general order by broadcasting intimate images of another without their consent. On 8 June 2021, consistent with the plea agreement, the military judge sentenced him to forfeit \$1,000 per month for 1 month, reduction in rank to paygrade E-1, and confinement for 40 days. The plea agreement contained a waiver of the accused's administrative separation board.

- At a Special Court-Martial in Groton, Connecticut, CSSR Joshua H. Roehr, USN, pled guilty pursuant to a plea agreement to three specifications of wrongful use of a controlled substance. On 30 June 2021, consistent with the plea agreement, the military judge sentenced him to confinement for 85 days and a Bad Conduct Discharge.

Navy Region Southeast

General Court-Martial

- At a General Court-Martial in Mayport, Florida, SN Jacquez D. Codymiles, USN, was tried for two specifications of rape, two specifications of aggravated sexual contact, two specifications of aggravated assault, and one specification of assault consummated by a battery. On 11 June 2021, the panel of members returned a verdict of guilty to one specification of rape, one specification of aggravated sexual contact, and one specification of assault consummated by a battery and sentenced him to forfeit all pay and allowances, reduction in rank to paygrade E-1, confinement for 54 months, and a Dishonorable Discharge.
- At a General Court-Martial in Charleston, South Carolina, HA Ethan J. Helems, USN, was tried for involuntary manslaughter, negligent homicide, reckless operation of a vehicle, leaving the scene of a vehicle accident, and false official statement. On 17 June 2021, the panel of members returned a verdict of guilty to involuntary manslaughter, negligent homicide, reckless operation of a vehicle, leaving the scene of a vehicle accident, and false official statement and sentenced him to reduction in rank to paygrade E-1, confinement for 30 months, and a Bad Conduct Discharge.

Special Court-Martial

- At a Special Court-Martial in Pensacola, Florida, PFC Marco A. Andarabracamonte, USMC, pled guilty pursuant to a plea agreement to wrongful use of a controlled substance, wrongful introduction of a controlled substance with intent to distribute, and four specifications of wrongful distribution of a controlled substance. On 16 June 2021, consistent with the plea agreement, the military judge sentenced him to reduction in rank to paygrade E-1, confinement for 4 months, and a Bad Conduct Discharge.

Navy Region Northwest

General Court-Martial

- At a General Court-Martial in Bremerton, Washington, MA2 Erik D. Miller, USN, was tried for assault consummated by a battery, two specifications of sexual assault, and two specifications of abusive sexual contact. On 24 June 2021, the panel of members returned a verdict of guilty to assault consummated by a battery, two specifications of sexual assault, and two specifications of abusive sexual contact and the military judge

sentenced him to reduction in rank to paygrade E-1, confinement for 40 months, and a Dishonorable Discharge.

- At a General Court-Martial in Bremerton, Washington, ETV1 Yusef R. Ali, USN, pled guilty pursuant to a pretrial agreement to indecent recording and three specifications of possession of child pornography. On 28 June 2021, the military judge sentenced him to reduction in rank to paygrade E-1, confinement for 48 months, and a Dishonorable Discharge. The pretrial agreement had no effect on his sentence.

Special Court-Martial

- At a Special Court-Martial in Bremerton, Washington, MASN Reginald S. Williams, USN, was tried for willful dereliction of duty for failing to follow firearm safety protocols and assault consummated by a battery. On 14 June 2021, the military judge found him guilty of willful dereliction of duty for failing to follow firearm safety protocols and assault consummated by a battery and sentenced him to reduction in rank to paygrade E-2 and confinement for 30 days.

Navy Region Southwest

General Court-Martial

- At a General Court-Martial in San Diego, California, HN James D. McNichol, USN, was tried for two specifications of sexual assault. On 10 June 2021, the panel of members returned a verdict of guilty to one specification of sexual assault and sentenced him to reduction in rank to paygrade E-1, confinement for 12 months, and a Dishonorable Discharge.
- At a General Court-Martial in San Diego, California, an E-3 was tried for sexual assault. On 25 June 2021, the panel of members returned a verdict of not guilty.

Special Court-Martial

- At a Special Court-Martial in San Diego, California, an E-6 was tried for two specifications of failure to go to his prescribed place of duty. On 15 June 2021, the military judge returned a verdict of not guilty.
- At a Special Court-Martial in San Diego, California, MM3 Calvin Francisco, USN, pled guilty pursuant to a plea agreement to misprision of a serious offense. On 29 June 2021, consistent with the plea agreement, the military judge sentenced him to reduction in rank to paygrade E-3 and confinement for 5 months. The plea agreement contained a waiver of the accused's administrative separation board.
