

The following reports the results of every Special and General Court-Martial tried and convened within the United States Navy in May 2020. The cases are separated by the Navy Region in which they were tried.

Naval District Washington

General Court-Martial

- None.

Special Court-Martial

- At a Special Court-Martial in Washington, DC, YN1 Matthew M. Rosario, USN, pled guilty pursuant to a pretrial agreement to forgery and conspiracy to commit fraud. On 28 May 2020, the military judge sentenced him to reduction in rank to paygrade E-3 and confinement for 4 months. Pursuant to the pretrial agreement reduction in rank below the paygrade of E-4 is to be disapproved. The pretrial agreement contained a waiver of the accused's administrative separation board.

Navy Region Mid-Atlantic

General Court-Martial

- At a General Court-Martial in Norfolk, Virginia, SN Joshua R. Adad, USN, pled guilty pursuant to a pretrial agreement to five specifications of wrongful distribution of a controlled substance, two specifications of wrongful possession of a controlled substance with intent to distribute, and three specifications of wrongful possession of a controlled substance. On 22 May 2020, consistent with the pretrial agreement, the military judge sentenced him to be discharged with a Dishonorable Discharge, reduction in rank to paygrade E-1, and confinement for 36 months.

Special Court-Martial

- At a Special Court-Martial in Norfolk, Virginia, ABHAR Leal L. McPhaul, USN, pled guilty pursuant to a pretrial agreement to desertion terminated by apprehension, unauthorized absence, missing movement through design, breaking restriction, willful disobedience of a petty officer, and four specifications of wrongful use of a controlled substance. On 14 May 2020, consistent with the pretrial agreement, the military judge sentenced him to be discharged with a Bad Conduct Discharge and confinement for 94 days.
- At a Special Court-Martial in Norfolk, Virginia, MM3 Andrew G. Smith, USN, pled guilty pursuant to a pretrial agreement to two specifications of assault consummated by a battery and four specifications of sexual harassment. On 15 May 2020, consistent with

the pretrial agreement, the military judge sentenced him to be discharged with a Bad Conduct Discharge, reduction in rank to paygrade E-1, and confinement for 3 months.

Navy Region Northwest

General Court-Martial

- At a General Court-Martial in Bremerton, Washington, AO3 Jose R. Martinez, USN, pled guilty pursuant to a pretrial agreement to attempted sexual abuse of a child, soliciting a minor to produce child pornography, receipt of child pornography, possession of child pornography, viewing child pornography, and indecent language. On 14 May 2020, consistent with the pretrial agreement, the military judge sentenced him be discharged with a Dishonorable Discharge, reduction in rank to paygrade E-1, and confinement for 132 months.
- At a General Court-Martial in Bremerton, Washington, MMN2 David W. Martinez, USN, pled guilty pursuant to a pretrial agreement to one specification of conspiracy to wrongfully use and distribute a controlled substance, three specifications of wrongful distribution of a controlled substance, and three specifications of wrongful use of a controlled substance. On 28 May 2020, consistent with the pretrial agreement, the military judge sentenced him to be discharged with a Bad Conduct Discharge, reduction in rank to paygrade E-1, and confinement for 16 months.

Special Court-Martial

- At a Special Court-Martial in Bremerton, Washington, AO3 Aqmera Am Khett Benu Williams, USN, pled guilty pursuant to a pretrial agreement to one specification of wrongful distribution of a controlled substance, three specifications of wrongful use of a controlled substance, and one specification of attempted wrongful possession of a controlled substance with intent to distribute. On 11 May 2020, consistent with the pretrial agreement, the military judge sentenced him to reduction in rank to paygrade E-1 and confinement for 90 days. The pretrial agreement contained a waiver of the accused's administrative separation board.

- At a Special Court-Martial in Bremerton, Washington, MTCS Jeremy T. Reardon, USN, pled guilty pursuant to a pretrial agreement to violating a protective order, reckless operation of a vehicle, and assault consummated by a battery upon a spouse. On 12 May 2020, consistent with the pretrial agreement, the military judge sentenced him to confinement for 35 days. The pretrial agreement contained a waiver of the accused's administrative separation board.
- At a Special Court-Martial in Bremerton, Washington, ETR3 David M. Diaz, USN, was tried for willful dereliction of duty, reckless endangerment, and simple assault. On 27 May 2020, the military judge returned a verdict of guilty of willful dereliction of duty and simple assault and sentenced him to reduction in rank to paygrade E-3 and confinement for 30 days.

Navy Region Southwest

General Court-Martial

- At a General Court-Martial in San Diego, California, FCC Benedict J. Lauchang, USN, pled guilty pursuant to a pretrial agreement to viewing child pornography. On 19 May 2020, the military judge sentenced him to be discharged with a Bad Conduct Discharge, reduction in rank to paygrade E-1, and confinement for 18 months. Pursuant to the pretrial agreement all confinement greater than 12 months is to be suspended. The suspended punishment may be served if the service member violates the terms of the pretrial agreement.
- At a General Court-Martial in San Diego, California, HM1 Timothy Bork, USN (retired), pled guilty pursuant to a pretrial agreement to sexual assault of a child and four specifications of sexual abuse of a child. On 15 May 2020, the military judge sentenced him to be discharged with a Dishonorable Discharge and confinement for 6 years. The pretrial agreement had no effect on his sentence.

Special Court-Martial

- At a Special Court-Martial in Yokosuka, Japan, PR3 Loren D. Anderson II, USN, pled guilty pursuant to a pretrial agreement to false official statement and wrongful use of a controlled substance. On 1 May 2020, the military judge sentenced him to a reprimand and reduction in rank to paygrade E-1. The pretrial agreement had no effect on his sentence. The pretrial agreement contained a waiver of the accused's administrative separation board.
- At a Special Court-Martial in Yokosuka, Japan, HN Trey L. Watson, USN, pled guilty pursuant to a pretrial agreement to false official statement and two specifications of wrongful use of a controlled substance. On 15 May 2020, the military judge sentenced him to reduction in rank to paygrade E-1 and confinement for 6 months. Pursuant to the pretrial agreement all confinement greater than 90 days is to be suspended. The suspended punishment may be served if the service member violates the terms of the pretrial agreement. The pretrial agreement contained a waiver of the accused's administrative separation board.
